To Whom It May Concern:

This letter is to inform you of a physical address change for *COEUR DU LAC CONDO*, located in the Town of Dillon. Please see the attached map for detailed location of this condominium.

Please note that this condominium originally received its Certificate of Occupancy with an address of 312 Lodgepole ST. The access to the property is from W La Bonte ST. Over the years this has caused confusion on the correct address of the building. Half of the current units are addressed 312 W La Bonte ST and the other half are addressed 312 Lodgepole ST. After further discussion with emergency services it has been determined that from this point forward the Coeur Du Lac Condominium address shall be **311 W La Bonte ST**. This decision is based on how to route emergency vehicles to the location that best accesses the building. The access to the property is on the odd numbered side of W La Bonte ST. See the table below for a complete list of addresses for all the units in Coeur Du Lac Condominium and their correct physical addresses.
